1. Housing data base of the county

2. Bad Landlord Bill - Chuck Thomas

Progress report – Researched yielded little information on any existing laws in the country.

3. Public Nuisance Bill - Chuck Thomas

- Aimed at neglected vacant properties
- Fines
- Ultimately eminent domain law to seize property

Progress report – Minnesota has excellent program for public and private nuisance. Maryland has no laws. Different local counties deal mainly with community associations. Columbia Association has revised its policy on Abandoned Homes. Local jurisdictions have differing laws to declare "blighted property." Eminent domain scope is being broadened to go beyond public works to cover community development.
