I have been a proud Oakland Mills resident for the past thirty-eight years. I cherish OM's open spaces, paths, schools, pools, and community spirit. As a bicycle advocate, I prioritize a safe, walkable, and bikeable community. Safe multi-modal transportation is for everyone, including children walking to school, bicyclists shopping at our farmer's market, drivers headed to Walgreens, or those commuting across the pedestrian bridge.

Some accomplishments of the OM Public Space Committee, which I chair:

- Proposed a crosswalk connecting the Thunder Hill neighborhood to businesses across Rte 108 (Projected completion in 2025)
- Advocated for ADA-compliant curbs at crosswalks on Thunder Hill, Log Chain, Farewell Roads (all complete), and soon Blue Coat.
- After cars struck two people at Stevens Forest and Kilimanjaro one week apart, we pushed for safety improvements to Stevens Forest Rd. Howard County has now installed improved pedestrian signaling to make this intersection safer.
